

AVVA - Who we are

Each year, dedicated Associates of Vietnam Veterans of America Inc. (AVVA) members volunteer infinite hours in support of our brave men and women who served in defense of this great nation. Our membership consists of veterans from all eras, their families and citizens who are committed to the welfare of those who served.

AVVA has established a formidable curriculum comprised of printed materials (Paper Safe, DIC Brochure, Children's Toxic Exposure Brochure), on-site educational seminars, nationwide Agent Orange Town Hall Meetings, secondary Post-Traumatic Stress Disorder (PTSD 2), Spousal and Survivor Benefits Seminar.

Our Purpose

AVVA is dedicated to the aggressive advancement of realistic goals, while maintaining integrity and a spirit of unity that reflects its commitment to Vietnam Veterans of America, Inc., and to veterans of all eras and their families. We accomplish this through cooperative projects and programs which facilitate, enhance and improve communication with our members and the public.

AVVA is not an auxiliary. Any person committed to the purpose of AVVA, regardless of their age, race, sex or creed, may apply for membership in our organization. We welcome veterans of all eras to join. Our goal mirrors VVA's motto: "Never again will one Generation of Veterans Abandon Another".

AVVA, a non-profit organization exempt from federal taxes, began as a 501(C)4 incorporation. It has since been determined that it can best serve veterans and their families by converting to a 501(C)3. This change permits us to solicit funding and accept tax-deductible donations which will sustain educational and other programs for veterans and their families. The IRS status conversion was initiated and completed in 2018.

AVVA is structured to:

- (a) support the values, goals, and exceptional works of Vietnam Veterans of America.
- (b) continue independently after VVA closes business.

VVA was set up to have an end date, as they are only allowed members who served during the Vietnam War. AVVA, having the ability to include anyone, was designed to be a perpetual organization, and looks to a future in which we carry on with our programs, and serve our veterans and their families.

The Origin of the AVVA

Associates of Vietnam Veterans of America, Inc. began as a group of people dedicated to advancing the work of Vietnam Veterans of America, Inc. (VVA). For many years prior to 1999, people who were friends or family members of Vietnam Veterans of America were members of VVA as non-voting associate members. Our first AVVA National Liaison was Linda Wilson of Florida in 1986. At that time VVA appointed the AVVA Liaison to their board.

By 1998, VVA was notified by the IRS that they had exceeded the limit of non-veteran members, and had to accept that their concern for their congressional charter left them at a turning point. The associates had grown in number, and by IRS standards, had to branch off into a separate organization, that is dependent on the parent organization to exist.

In January 1999 AVVA formally incorporated as a separate organization from VVA, although we have never separated ourselves in spirit or in our activities. The first official bylaws for Associates of Vietnam Veterans of America were adopted, and the first national officers were sworn in at a two-day meeting in Orlando, FL. Since then we have evolved from a 'sister' organization to an independent membership and support organization, working side-by-side with VVA on both agendas.

In August of 2000, the first official convention for AVVA was held in Buffalo, NY, electing the first official officers and regional directors. Bylaws were then amended and adopted by the state representatives.

From 2000 to 2010, AVVA held its elections and conventions in even numbered years. Our conventions coincided with the VVA Leadership Conferences. In 2010 AVVA's membership voted to change our convention years to odd numbered years. This gave us the opportunity for greater attendance of AVVA membership, and our conventions and leadership conferences would now coincide with VVA.



In 2002 states began to incorporate as subsidiaries of the national organization. The first state to incorporate was Illinois.

In 2004, the national bylaws were amended to allow chapters to become incorporated within their own states. In approximately 2011 or 2012, the organization made the distinction between incorporated and unincorporated chapters and states.

Due to the change in convention years from even to odd, the 2010 board of directors and all state and chapter representatives and presidents served a three-year term, setting our first odd year convention in 2013. Since that time, all conventions are held in odd numbered years, and all terms of office for all levels were set as two year terms. The 2019 convention in Spokane, WA will mark AVVA's 10th National Convention and its 20th anniversary.

The AVVA Logo



The AVVA logo has been in use since we incorporated. Our logo is a variation of the VVA logo, (a design based on the Vietnam Service Ribbon). This was done to show our direct affiliation with, and respect for, VVA. We added the rocker at the bottom stating "Together Always ©" as our promise to always work alongside VVA. The name, Vietnam Veterans of America, Inc. (VVA) and the VVA logo are copyrighted. Therefore, our name and logo are used with the express written permission of VVA.

Due to the special license agreement that exists between the two organizations, permitting AVVA to use the derivatives of the VVA copyrighted logo and name, anyone who wishes to use the name or logo must first get permission to do so from National AVVA.

The AVVA flag uses the opposite base color (green) of the Vietnam Veterans of America flag (yellow) to distinguish the two. Both flags are based on the colors of the Vietnam Service Medal.



Organizational Structure

Prior to 1999, AVVA positions were known as "Liaisons" to VVA, and were appointed by the VVA chapter, state, or national presidents and regional directors. When AVVA incorporated as a national organization, legally independent of VVA, bylaws were crafted to require elections within the AVVA membership.

In 2000, at the first AVVA National Convention, the state representatives, derived from the existing state "liaisons" elected the first official national officers and regional directors.

In 2001, the first official elections were held for positions of state representatives.

April 2001, the Associates affiliated with VVA chapters elected their first affiliated chapter representatives. For the first election, there were no guidelines outside of holding regular membership in the corporation. The most important issue was for the AVVA members

affiliated with each VVA chapter to have elected representation. Until 2013 only state representatives or presidents voted at national conventions. During the 2010 convention, policy was changed to include chapter presidents and representatives, and at-large representatives, as voting delegates.

Currently, AVVA holds its elections for chapters and states in even numbered years, and its conventions in odd numbered years.

In April of 2019 the AVVA Board of Directors adopted a Strategic Plan outlining our needs to remain a perpetual organization.

Membership

Currently, AVVA has 1173 members who were members when AVVA incorporated in January 1999 and who are still members. Of those members 125 continue to pay either annual or three-year membership dues, and the rest are Life Members.

We now have more than 10,215 members spread across all 50 states and three territories; Guam, the Philippines and Puerto Rico. There are 12 states that are incorporated with elected officers, 18 states having elected representatives, and 20 states with no elected representation.

Chapter Status

AVVA has 559 chapters with 52 states and territories having At-Large members. 18 of the 559 chapters are incorporated. Chapter incorporation requires a minimum of 10 members. We have 289 chapters that are below the required number of members to consider incorporation. That is 51% of the 559.

We have 51 chapters with 1 member. Our largest chapter has 301 members. There are nine chapters that have 100 or more members; 2 of them incorporated. 745 of our 10,000+members are in incorporated chapters.

Of the more than 10,215 current members, at least 6,925 are life members. At least 2,349 are annual or 3 year, and at least 496 are dual members. The region with the highest number of members is region 3, followed closely by region 2. (Numbers are as of 4/30/19)

Historical Information

Donations to other organizations and to our members

In 2000 Associates of Vietnam Veterans of America (AVVA) asked Vietnam Veterans of America (VVA) to be included



in the Project Friendship program. Since that time, it has become an AVVA/VVA project. Over the years AVVA collected more than \$90,500 in donations to deserving Veteran related charities in the cities in which our conventions and leadership conferences were held. These donations came from our members, both VVA and AVVA. Our members should be very proud!



Other Grants: Over the years AVVA has donated more than \$7500.00 in grants to Veteran Related Organizations and to others, in the form of our Helping Hands Grants (formerly named Homeless Grants).

The Paper Safe: Around the time that we were incorporating AVVA, a member had been emailing Nancy Switzer about her husband's health; he had cancer and serious PTSD. They talked for hours on the phone and through email. One day, the wife contacted Nancy and told her that her husband had passed away. While going through his personal things, she found his DD214 and realized that he was a decorated veteran who could have been buried with military honors. Later, the woman's daughter contacted Nancy and told her that her mother had committed suicide because she felt so much guilt. Nancy Switzer realized then that we needed to educate our spouses and families on survivor benefits and the need for keeping records for our families. Nancy Switzer worked with an attorney who dealt with estate planning, Len Selfon, the then VVA Benefits **Publications Origins**

The Paper Safe, a vital tool for preparing and keeping records and documents for our families.

and they created the Paper Safe. It was presented to the AVVA National Board of Directors and was unanimously adopted. The demand for Paper Safes is becoming overwhelming. Because of the expense and the overwhelming requests, we have begun asking for donations from the requesters specifically for the postage.

Director, Mokie Porter, Communications Director and Xande Anderer,

DIC Brochure - Survivor Benefits: This brochure was developed because, as the director of Veterans' Benefits for AVVA, Nancy Switzer saw a need in our chapters and states for a handout of some kind that educates our members about their benefits, and would advise them to see an accredited Service Officer for help after their veteran passed. The brochure gives our members the basics about the benefits that a spouse or family member might be entitled to upon the loss of their Veteran.

Children's (Agent Orange) Brochure: This brochure was created by our AVVA committee on Toxic Exposure with the help of Mokie Porter, Communications Director for VVA. It was created from our town hall meetings as a hand out, for families to follow if they felt their child was affected by their parents' exposure to toxins while in service. We have found that there are now at least three generations affected by toxins, and we wanted the public to understand.

The VISTA Program

A program started by AVVA in 2014. This program was developed by our past Vice-President, Cathy Keister, who believed we should be tracking rewarding our commitment. This program tracks the thousands of hours our members work to serve their communities. Our members volunteer their time helping the disabled, visiting patients in hospitals, organizing and running community and fundraising events, working in nursing homes and hospice facilities, driving people to doctor appointments or on daily errands, and a host of other tasks to help in their local areas.







VISTA was developed as a means of tracking those hours and rewarding our members for their selfless actions. Members, chapters, states and regions with the highest total hours reported are awarded each year at conventions and conferences. To date, we have tracked over 98,238 hours - and these are just the hours that have been reported.

It is estimated that AVVA members donate over 1,000,000 a year. We can only acknowledge those hours that are reported.

In Memory Plaque



Ruth Coder Fitzgerald spearheaded a national campaign to place a memory plaque at the Vietnam Wall in Washington, DC honoring veterans who fought in Vietnam and died later of combat-related causes, such as the effects of Agent Orange.

Fitzgerald was certain that her brother, John Coder, an Air Force helicopter pilot in Vietnam died of Non-Hodgkin's Lymphoma in 1992, was a victim of Agent Orange exposure.

Her determination and diligence for 8 years resulted with an act of Congress to place the 'In Memory Plaque' at the National Mall in Washington, DC.

In November of 2004, the 'In Memory Plaque' was dedicated to all those who died from physical and/or psychological illnesses as a result of their service in Vietnam.

Soon after the dedication the plaque began to deteriorate and was in need of repair or replacement. In approximately 2011-2012, the staff at the Arts Council was approached by two widows (AVVA members) to plea for restoration of the plaque.





To restore the dignity of the plaque, the redesign had to have the approval of three government agencies: Council of Fine Arts (CFA), the National Park Service (NPS) who would maintain it, and the DC Planning Commission (DCPC).

Architect J.C. Cummings created two beautiful designs. Both were rejected by the CFA. We later learned that a redesign that might possibly upstage The Wall would never be accepted. So, a past member of the CFA Board gave us advice on what would be accepted: slightly elevated, no more than 4 inches.

In 2015, Vietnam Veteran Memorial Fund (VVMF) contacted AVVA President, Sharon Hobbs, to suggest a partnership to complete the repair. Jim Knotts, CEO of VVMF, gave comprehensive assistance needed to help AVVA complete the task. With VVMF's clout, assistance and financial support, the proposal for the plaque's repair was accepted in 2017. Materials and stone had been accepted. The Plaque's completion took another year.





That memorial was restored and rests in the grounds approximately between the Vietnam Memorial Wall and the statue of the Three Soldiers.

The re-dedication was on Memorial Day 2019. Although the design was not what AVVA first envisioned, it is now easy to find, and has a presence.

The plaque reads: "In memory of the men and women who served in the Vietnam War and later died as a result of their service. We honor and remember their sacrifice."


