**General Orders:**

**A. State Chapter Election Reminder:**

President Hobbs reminded attendees that 2024 is an election year for the states and chapters. Regional Directors should ensure that their respective states and chapters meet elections deadlines, comply with elections policies and complete all elections documents accurately and on time.

Secretary Schloffel will work with Elections Chair Nancy Montgomery to prepare a Mailchimp announcement that provides elections information. The Mailchimp elections announcement is to be distributed by mid-February.

**B. VVA Financial Donation:**

President Hobbs announced that AVVA received an \$80,000 donation from VVA. This donation reflects the amount that VVA failed to collect for our hotel rooms over the past four years. At the direction of VVA Treasurer Wayne Reynolds, the \$80,000 was written off.

**C. Awards Reminder:**

On behalf of Awards Committee Chair, Tony Gigli, Secretary Schloffel announced that the deadline for awards nominations is May 31<sup>st</sup>. Secretary Schloffel agreed to distribute a Mailchimp announcement to that effect and will have the awards deadline posted on the website.

**D. Digital Document Update:**

Treasurer Kaye Gardner reported that she identified three companies that digitize printed documents. Treasurer Gardner will contact each company to determine pricing. President Hobbs noted that we should also determine if the digitizing process will be done on or off site.

**E. Flag Booklet:**

Prior to the meeting, the Board reviewed a prototype for a booklet on flag etiquette. While the booklet is factually accurate, it was still being edited. The Board was asked to evaluate the booklet solely for the message it presents and its formatting. The Board was to be prepared to vote on moving forward with producing the booklet. President Hobbs added that AVVA and VVA's Veterans Against Drugs

**F. Veterans in the Justice System Update:**

At a recent meeting of Veterans in the Justice System, President Hobbs and VIJS Chair, Dominic Yezzo, discussed transitioning the program to AVVA. Both agreed that a younger AVVA member, who is a veteran, should lead the transition process.

AVVA member Julie Hayes (FL) is a young Navy veteran who is deeply involved with Florida’s established VIJS program. Julie comes highly recommended by VVA Florida State Council President, John McGinty. Julie is also a member of AVVA’s VIJS partner program, Members in the Justice System.

The Florida State Council funded travel expenses for Julie to attend the January meeting of VIJS. Julie and Program Chair Yezzo had very positive discussions regarding the welfare of incarcerated veterans and how VIJS is responding to their needs. This is a great start in positioning AVVA to assume the leadership role for the Veterans In The Justice System program.

**G. Project Friendship:**

President Hobbs announced that **Horsemanship for Heroes** has been selected as AVVA’s 2024 Project Friendship. VVA Project Friendship Advisor, Sandy Miller, evaluated this charity, along with other veterans charities in the Reno area, before recommending **Horsemanship for Heroes**.

As published on its website, **Horsemanship for Heroes** ‘promotes the healing and well-being of veterans, emergency responders, and their families through equine-assisted psychotherapy and learning, empowering them to build resilience, self-awareness, and personal growth’.

If accepted by the Board, an announcement naming **Horsemanship for Heroes** as AVVA’s 2024 Project Friendship partner will be made at the VVA Board of Director’s meeting in April. Flyers for Project Friendship will be distributed at that time.
