Good news – AVVA recently received a \$500 donation to the Flag Booklet Program. This will be used to offset shipping.

Mailchimp Update:

Data compiled from current AVVA membership rosters has been uploaded into Mailchimp. This effort increased our Mailchimp audience base from less than 4,000 email subscribers to over 9.400.

Chapel of the Four Chaplains:

Last October, Dennis Beauregard and Dave and Elaine Simmons, presented an overview of the honorary society, Chapel of the Four Chaplains. Purpose of the presentation was to encourage previous inductees to nominate other AVVA members for a Chapel of the Four Chaplains Legion of Honor Award. To date, the Chapel has not received any award nominations from AVVA. President Hobbs encourages eligible AVVA honorees to nominate a deserving AVVA colleague. Awardees will be recognized during a ceremony at the National Convention.
